Lympstone pre-school

The Council considered this at the meeting on 4th April 2016. The following minute was recorded.

257 Use of land in Candy's Field. The report of the Clerk set out the processes that would have to be followed if the Parish Council was to dispose of any land in candy's Field. Cllr Longhurst gave a presentation which brought the Council up to date on the progress of the setting up of the Lympstone Community Foundation. Foundation Members had held discussions with the VHMC regarding the acquisition and development of land at the Village Hall but these were not successful. They now put forward a proposal to develop land adjoining the Youth Club on the site of the Youth Shelter. Mr Mingo had confirmed that this was not used and could be removed. The proposal was for a building of approximately 140 sq. m. and would accommodate the Lympstone Pre-school. Having their own building would give an opportunity to reduce operational costs and produce income in order to remove the current funding deficit. The Cherry trees in front of the Youth Shelter might have to be removed but there could be new planting to off-set this. Cllr Dimond asked if there was a business plan in place for the operation and management of the building when it was ready, which would show that the Pre-school was sustainable and whether there was a brief for the building. Cllr Lyon would manage the project and confirmed that all this would need to be in place before any commitments would be given. Cllr Longhurst suggested that the building would be leased to the Pre-school at a commercial rent and this would be commuted by way of a grant from the Foundation. The Pre-school would need to find the internal operating costs for the building. RESOLVED: that this matter be considered further at the next meeting.

At the next meeting Cllr Longhurst reported that, at that time, there seemed to be scope for agreement with the Village hall committee regarding a site for the building.

The following is an extract from the Lympstone Pre-school website:

"Our Pre-school

We are a village pre-school on the edge of the seaside resort of Exmouth. As a community run preschool we are entirely owned and run by the parents of those children attending the group and depend on these volunteers. The pre-school is administered by a committee of volunteers who are elected annually at the A.G.M. The Committee is responsible for employing the staff: the Playleader, Deputy, Assistants and Learning Support Assistants. Our extremely dedicated staff are responsible for the day to day running of pre-school. The Preschool is OFSTED Registered (No. URN105994) and a Registered Charity (No. 1038447). We are also affiliated with the Preschool Learning Alliance (PLA). This site is designed to be a source of information on our pre-school and Toddler group and it's activities and to provide you with additional information related to early years education."
