Activity	Visitor and Clubs Site Risk Assessment				

Description:

This is a risk assessment of the visitor routes at Cliff Field split in to high, medium and low-level use.

The use of the field takes account of different levels of use and types of activity, reflecting the numbers of people that use the area and the time that they spend in that area. The risk assessment follows the guiding principles of the 'managing visitor safety in the countryside; principles & practice' guidance produced by the Visitor Safety in the Countryside Group and is relevant for visitors to site, contractors, councillors, scouts and Lympstone Football Club (LFC). Any specific activities carried out on the site are covered through other risk assessments. Cliff Field is used daily by dog walkers and people using the footpaths to, from and around the field. The field hosts beautiful views across the estuary and is surrounded by part hedge and trees on the boundary and along the cliff edge. Once a week, the scouts and football club use the field. The scout group have their own hut on site. The football club have a marked football pitch with two goal posts and two toilets on site. (Toilets only accessible when opened by LFC). The field is used occasionally for community events. Both the scouts and LFC have their own risk assessments written and insurance. Both groups have provided LPC with copies of these. The field is easily accessible by vehicle, but the vehicular gate is permanently locked unless permission is granted. The field has three pedestrian gates to access the field. DCC has a marked footpath into and through the field.

Beach hazards

LPC does not take responsibility for hazards at sea, this role is taken on by other organisations such as Heritage England, the Harbour Board and Exe Estuary Partnership Management. The estuary is not manned.

Severity of the hazard:

How serious are the consequences likely to be? Extreme (fatality) / Serious (major injury or serious ill health / Moderate (minor injury)

Likelihood of the event:

How likely is it that the event will occur? Remote / Possible / Likely

Adequacy of controls:

Are existing precautions adequate? Good (most precautions in place) / Fair (some deficiencies) / Weak (serious deficiencies)

In sections there is a sheer drop from the cliff edge of 20ft to the estuary below. Vegetation is left uncut along the cliff edge to prevent users approaching too close to the cliff edge. The path surface around the field is a grassy track but due to large numbers of visitors this is now bare earth in several places. The path surface can get muddy and as a result slippery in times of persistently wet weather. During such periods of wet weather, the path surface will be checked and if necessary, temporary signage will be erected and a path diversion to an alternative route considered.
