CRANBROOK: **No Waiting At Any Time** on specified lengths of Barn Orchard, Best Park, Copseclose Lane, Crabtree Close, Crannaford Lane, Seven Acres, Three Corner Field, Tillhouse Road, Yonder Acre Way and Younghayes Road

EXMOUTH: **No Waiting At Any Time** on specified lengths of Albion Place, Bapton Lane, Beacon Place, Burntside, Elm Grove, Exeter Road, Hulham Road, Louisa Place, Maer Vale, Nutbrook, Oldfields, Rivermead Avenue, Point Terrace, Trefusis Place and Victoria Place; **School Entrance Clearway – No Stopping At Any Time** on a specified length of Withycombe Village Road; **Buses Only At Any Time** on a specified length of Marley Road

FENITON: School Entrance Clearway - No Stopping At Any Time on specified lengths of Station Road

HONITON: No Waiting At Any Time on a specified length of Streamers Meadows

LYMPSTONE: **No Waiting At Any Time** on specified lengths of Church Road, Courtlands Lane, Longbrook Lane, Longmeadow Road, Malt Field, Sowden Lane and Strawberry Hill; **Buses Only At Any Time** on a specified length of Exmouth Road

SEATON: No Waiting At Any Time on a specified length of Harepath Road

SIDBURY: **No Waiting At Any Time** on a specified length of Hillside

SIDMOUTH: **No Waiting At Any Time** on specified lengths of Balfours, Bickwell Valley, Higher Fortescue, Sid Road and Woolbrook Road
