#### **Description:**

This is a risk assessment of the visitor routes at Candy's Field split in to high, medium and low-level use.

The use of the field takes account of different levels of use and types of activity, reflecting the numbers of people that use the area and the time that they spend in that area. The risk assessment follows the guiding principles of the 'managing visitor safety in the countryside; principles & practice' guidance produced by the Visitor Safety in the Countryside Group and is relevant for visitors to site, contractors, Lympstone Primary School, Youth Club, Pre-school and Lympstone Football Club (LFC). Any specific activities carried out on the site are covered through other risk assessments. Candy's Field is used daily by dog walkers and people using the footpaths to, from and around the field, the field includes a MUGA, toddler play area, activity trail, tree trunk scrambler and two training football pitches. There are the Youth Club and Pre-school buildings on site. The local primary school access and regularly use the field for educational purposes. The field is used occasionally for community events. The Primary school, pre-school, youth club and football club have their own risk assessments written and insurance. All groups have provided LPC with copies of these. The field is easily accessible by vehicle, but the vehicular gate is permanently locked unless permission is granted. The field has three pedestrian gates to access the field.

### **Severity of the hazard:**

How serious are the consequences likely to be? Extreme (fatality) / Serious (major injury or serious ill health / Moderate (minor injury)

#### Likelihood of the event:

How likely is it that the event will occur? Remote / Possible / Likely

#### Adequacy of controls:

Are existing precautions adequate? Good (most precautions in place) / Fair (some deficiencies) / Weak (serious deficiencies)
